- (ii) **The candidate must enclose the self-attested photocopies of the mark-sheets, certificates/degrees/Transitions ID (Fee Receipt) and other relevant documents with their application form.**
- (iii) The Reservation for the posts shall be applicable as per UGC Guidelines and GOI Rules.
- (iv) The remuneration payable to the Faculty shall be a fixed amount of Rs. 45,000/- per month.
- (v) The engagement of the Faculty is on purely temporary (self-finance) basis up to 31st of May 2027 or engagement of full scale faculty on contractual basis, whichever is earlier.
- (vi) No queries will be entertained in this respect.
- (vii) The eligibility of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories specified are permissible, based on only the qualifying marks without including any grace mark procedures.
- (viii) Only matriculation/SSC certificate/passing certificate issued by the concerned educational board will be considered as proof of date of birth. No other document will be accepted for verification of date of birth.
- (ix) Candidates belonging to SC/ST/OBC category should submit proper caste certificate as per the proforma of Govt. of India.
- (x) Candidates belonging to OBC category, but failing in creamy layer will not be entitled to the benefits of reservation and should apply as Unreserved Category candidate.
- (xi) Candidates belonging to EWS category should submit proper certificate as per the proforma of Govt. of India.
- (xii) Candidates must ensure before applying that they are eligible according to the criteria stipulated in the advertisement.
